499	Italy	01/08/2026 – 01/09/2026	Threat to public policy, internal security, and the management of migration flows due to recent events in the Spanish autonomous city of Ceuta, resulting from large-scale irregular entries of third-country nationals, with a risk of secondary movements within the Schengen area; all internal air and sea borders with Spain.
498	Italy	24/07/2026 – 26/07/2026	Expected public-order and internal-security threats linked to the Festival dell'Alta Felicità in Venaus (Susa Valley), including likely participation of radical activists and possible violent actions against the Turin-Lyon railway construction sites and deployed law-enforcement personnel; land borders with France.
497	Denmark	12/07/2026 – 11/11/2026	Continued threats to public policy and internal security posed by possible sabotage actions by Russia, as well as ongoing terrorism-related incidents and organised crime, notably linked to the US-Israeli conflict with Iran and radicalisation by groups such as Islamic State and Al-Qaida with potential attacks on Jewish and Israeli targets; land and sea borders with Germany.
496	Austria	16/06/2026 – 15/09/2026	Continuous threats to internal security posed by irregular migration along the Balkan routes (including expected migratory pressure), as well as threats associated with the burden on the asylum reception system and basic services, Russia's ongoing war of aggression against Ukraine, and the security situation in the Middle East, aggravated by terrorist groups and the US-Israeli conflict with Iran; land and river borders with the Slovak Republic, and land borders with the Czech Republic, Hungary, and the Republic of Slovenia.
495	Italy	19/06/2026 – 18/12/2026	Continued threat of terrorist infiltrations into migratory flows along the Western Balkan route, ongoing crises in the Middle East and Ukraine, high level of irregular migration including a strong presence of criminal smuggling and trafficking networks; land borders with Slovenia.

494	The Netherlands	09/06/2026 – 30/09/2026	Continuous serious threat to public policy caused by high levels of asylum applications, irregular migration, migrant smuggling, and secondary movements, leading to an overburdening of the migration system and the asylum system, particularly, the reception capacity; land borders with Belgium and Germany, and the intra-Schengen air borders.
493	Switzerland	10/06/2026 – 19/06/2026	G7-summit, 15-17 June 2026 in Evian (France). Land borders (including the lake border on Lake Geneva) with France, with a focus on the Lake Geneva basin.
492	Norway	12/05/2026 – 11/11/2026	Continued general threat aimed at the energy sector, threats of sabotage posed by the Russian intelligence service, possibly targeting logistics infrastructure and civilian infrastructure; ports with ferry connections to the Schengen area.
491	Denmark	12/05/2026 – 11/07/2026	Continued threats to public policy and internal security posed by possible sabotage actions from Russia, as well as continuous terrorism-related events and organised crime, notably, tied to the Israeli-Iran conflict and driven by radicalisation from groups such as Islamic State and Al-Qaida. These threats include potential attacks on Jewish and Israeli targets; land and sea borders with Germany.
490	Sweden	12/05/2026 – 11/11/2026	Continued serious threats to public policy and internal security posed by organised cross-border crime and other criminal activities, including the involvement of foreign state actors leveraging criminal gangs, coupled with persistent threats from violent Islamist groups and individuals; all internal borders (land, air, and sea) and land borders with Denmark.
489	France	01/05/2026 – 31/10/2026	Continued serious threats to public order and internal security posed by persistent jihadist threats, a rise in antisemitic attacks, the growing criminal networks facilitating irregular migration and smuggling, and potential infiltration by radicalised individuals towards the Franco-British border, as well as the Channel and North Sea borders, along with rising violence among migrants, particularly in northern coastal areas such as Pas-de-Calais, creating dangerous conditions for migrants and law enforcement. Further threats involve, the deteriorated global security environment, including instability in Iran, the Middle-East, Afghanistan and Somalia, and the ongoing Russia–Ukraine war. Finally, the G7 will be hosted in Evian; all internal borders (land, air, and sea) with Belgium, Germany, Luxembourg, the Swiss Confederation, Spain, and Italy.

471	Slovenia	22/06/2025 – 21/12/2025	Serious threats to public policy and internal security posed by a high level of terrorist threats and organised crime, including human smuggling and arms trafficking, the risk of terrorist infiltrations into migratory flows via the Western Balkans, hybrid threats from the Russian Federation and Belarus, as well as instability in the EU's neighbourhood, including Russia's ongoing aggression against Ukraine and instability following the fall of Assad's regime in Syria; land borders with the Republic of Croatia and Hungary.

448	Germany	12/11/2024 – 15/03/2025	Security risks associated with irregular migration that increase serious threats to public order and security posed by the already tense reception situation for refugees, and the potential increasing migratory pressure at the EU's external borders because of developments in Afghanistan, Turkey, and Syria, as well as smuggling activities, Russia's ongoing war of aggression against Ukraine, and the security situation in the Middle East exacerbated by terrorist groups; borders with the Republic of Austria.
447	Norway	12/11/2024 – 11/05/2025	General threat aimed at the energy sector, threats of sabotage posed by the Russian intelligence service, as well as to increase infrastructure protection; ports with ferry connections to the Schengen area; all internal borders (land, air, and sea).
446	Norway	12/10/2024 – 22/10/2024	Serious threats to public order, internal security, and travellers from other Schengen Member States, along with increased terrorist threats, including potential attacks on Jewish and Israeli targets, tense relations between criminal groups, and ongoing conflicts, particularly in the Middle East; all internal borders (land, air, and sea).

445	Denmark	12/11/2024 – 11/05/2025	Serious threats to public policy and internal security posed by continuous terrorism-related events and organised crime, as well as Russia's ongoing aggression in Ukraine, Russian attempts of espionage, and acts of physical sabotage by individuals linked to Russia, along with the impact of Middle Eastern armed conflicts and conflicts in Africa increase migratory pressure, irregular entries, and risk infiltration by radicalised individuals; all internal borders (land, air, and sea), and land and sea borders with Germany.
444	France	01/11/2024 – 30/04/2025	Serious threats to public policy, public order, and internal security posed by high-level terrorist activities, the growing presence of criminal networks facilitating irregular migration and smuggling, and migration flows that risk infiltration by radicalised individuals, as well as the irregular crossings on the Channel and North Sea borders, along with rising violence among migrants, particularly in northern coastal areas such as Dunkirk and Calais, leading to tense and dangerous situations involving both migrants and law enforcement; borders with Belgium, Luxembourg, Germany, the Swiss Confederation, Italy, and Spain (land, air, and sea).
